There seems to be a lot of waste, dirty water and human waste along the pond. One camper has almost blocked the sidewalk with a wooden fence. Kalina said that contacting the City code compliance office with your complaint is the best way to get things done, all should leave or post online a complaint, so that they will see a priority with it.
 - Autumn Landscaping at Bancroft Ponds – Colleen reported that sometime in October some additional birding area plants and the classroom trees will be planted.
