Minutes of the June meeting were approved.

Action Plan draft:

- Our Action Plan should be on the agenda for the General Meeting in September.
- Next step is to create a maintenance policy for the bulletin boards placed in parks.
- This is an internal decision that is up to the City, to include what's to be posted.
- Where to locate a bulletin board in a park : must be ADA compliant, snow shoveling and mowing considered, must be perpendicular to the sidewalks for most visibility
- City will provide concrete and installation. No installation until next year. Question was asked about neighborhood doing the installation, Kalina will ask Parks.
- Who will be responsible for maintaining the information on the board.
- Wind direction needs to be considered.
- 2-sided board could show City information on one side and Neighborhood information on the other side.
- Kalina will bring this discussion to the Parks & Recreation department.

Alex moved/ Medora 2nd that we pay the \$136.47 for the sign placards for the sandwich boards to advertise the General Meeting. Motion carried. Alex will ask about erasable placards to save expenses of yearly updates.
